

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FRISCO, TEXAS, APPROVING THE APPOINTMENT OF DR. MARK A. GAMBER AS THE HEALTH AUTHORITY FOR THE CITY OF FRISCO FOR A TERM OF TWO (2) YEARS IN ACCORDANCE WITH SECTION 121.028 OF THE TEXAS HEALTH AND SAFETY CODE; APPROVING THE AGREEMENT BETWEEN THE CITY OF FRISCO AND DR. MARK A. GAMBER FOR PROFESSIONAL SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 121.028 of the Texas Health and Safety Code authorizes the City Council of the City of Frisco, Texas (“City Council”) to appoint a health authority to administer state and local laws relating to public health in the City of Frisco, Texas (“Frisco”); and

WHEREAS, the City Council has investigated and determined that it would be advantageous and beneficial to the citizens of Frisco to appoint a health authority in accordance with Section 121.028 of the Texas Health and Safety Code; and

WHEREAS, Frisco desires to appoint Dr. Mark A. Gamber to serve as the health authority for Frisco; and

WHEREAS, the City Council has investigated and determined that Dr. Mark A. Gamber is qualified to serve as the health authority for Frisco under Section 121.022 of the Texas Health and Safety Code; and

WHEREAS, the City Council finds that is in the best interest of the citizens of Frisco to approve Dr. Mark A. Gamber’s appointment as the health authority for Frisco.

NOW, THEREFORE, BE IT RESOLVED BY THE FRISCO CITY COUNCIL:

SECTION 1: Findings Incorporated. The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

SECTION 2: Approving Appointment. The City Council hereby appoints of Dr. Mark A. Gamber as the health authority for Frisco pursuant to Section 121.028 of the Texas Health and Safety Code.

SECTION 3: Term of Appointment. Dr. Mark A. Gamber’s appointment as health authority for Frisco shall be for a term of two (2) years.

SECTION 4: Authority of City Manager. The City Council hereby designates and authorizes the City Manager to execute the Agreement between Frisco and Dr. Mark A. Gamber for Professional Services, a copy of which is attached hereto as Exhibit A and incorporated herein for all purposes.

SECTION 5: Effective Date. This Resolution shall take effect immediately upon its passage.
